GIST OF THE CASE

The Complainant has filed the petition in the name of Jadumani Mahakul bearing Consumer No 4132-3506-0203 under JED, TPWODL, Jharsuguda has stated about billing dispute- he is unable to pay the billing amount due to excess billing.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents except ledger copies for the period from May'2018 to Dec'2024 in this case.

OBSERVATION AND ORDER

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 1kw with initial date of p/s 15.04.2010 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. It is observed that:-

- From Apr-May'2010 to Sep-Oct'2015 bills were PL/Avg. with some adjustment of old PL bills but some adjustments are yet to be done as per meter sl. no.345194.
- From Nov-Dec'2015 to Apr-May'2018 Avg. bills were served to the complainant as per meter sl. no.345194.
- 3. The meter sl. no.WLT069740 was installed during May-Jun'2018 and it is continuing till Dec'2024
- 4. As per the the meter sl. no.WLT069740 IMR as "492"kwh on 16.07.2018 and FMR as "2038'kwh on 10.01.2019 where the average consumption was 257.06 or say 258 units/month.

So, from the above observation it is seen that the bills were ok and there is no merit in the complaint and hence the instant case petition is hereby dismissed.

Accordingly, the case is disposed of.
