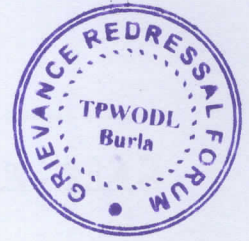

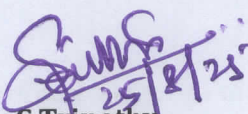

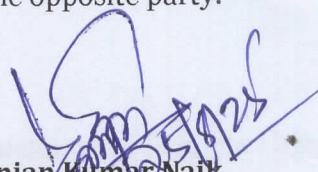
However, the opposite party is advised to resolve the case as per internal bill revision mechanism in force.
