GIST OF THE CASE

Sri Kishor Perua appeared in the hearing on Dt. 27.01.2025 at the camp held at ESO Office, Bagdihi and submitted a written complaint wherein he has raised objection about to abnormal & excess energy bill charged from Sept-2021 to Dec-2021. Hence, the complainant prayed before the Forum to redress the grievances accordingly.

SUBMISSION OF OPPOSITE PARTY

The opposite party could not submit any relevant documents in this case, after giving sufficient reasonable time to furnish.

OBSERVATION

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4131-2704-1128, having CD-2KW under LT-Domestic category, coming under ESO-Bagdihi & initial power supply effected on 20.05.2010 through meter SL No-'963457'. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- A new meter SL No-'WCG08770' was updated in billing during Dec-2015 billing. However, provisional and average bill were continued from Dec-2015 to Oct-2016.
- During Nov/Dec-2016 bi-monthly billing, actual bill was charged for the month, considering the advance dreading of KWh-'001303'. Thereafter, actual bills were continued up to June-2019, up to the advanced meter reading of KWh-'003820' recorded in meter SI No-'WCG08770'.
- 3. Subsequent bill were raised on provisional and actual basis intermittently from July-2019 to June-2021 wherein abnormal bill units of '1800' KWh was charged in the bi-monthly billing of Sept/Oct-2019, considering IMR-'3820' Kwh and CMR-'5620' KWh. It was revealed that provisional bills particularly from March-2020 to June-2021 were charged @31 units/month.
- The ledger abstract from FG data base (Licensee soft records) revealed that actual bills continued to charge from July-2021 onwards.
- The FG records indicated that a new meter SI No-'LW254389' was installed on 24.02.2022 and actual bills
 continued thereafter from Feb-2022 onwards and current outstanding as on Dec-2024 stood at Rs.4375.03/-
- 6. As per petition filed by the complainant objecting about abnormal bills charged from Sept-2021 to Dec-2021, the Forum observed that actual bills were raised as per the advanced meter readings recorded in meter SL No-'WCG08770' and no such billing anomalies were found. However, considering the excess bill raised in Sept/Oct-2019 as per consumption recorded in the above meter, the opposite party is required to revise the energy bill charged from July-2019 to Dec-2021, by recasting the accumulated units on monthly average basis, as recorded up to Dec-2021 billing.

ORDER

After careful consideration of hearing and documents, statements available on records, the Forum hereby passes order in consonance with Regulation of OERC Distribution (Conditions of Supply), Code, 2019.

- The Opposite Party is directed to revise the energy bills charged from Dec-2015 to Dec-2021 on the basis of recasting/spreading over the total accumulated units of KWh-'7390' as recorded in meter Sl No- 'WCG08770' during Dec-2021 billing, on monthly average basis from the date/month of installation of the same, duly adjusting the bill revision made earlier and/or, the benefit arising out of the OTS Scheme, if any.
- 2. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustments for the payments made by the complainant.
- 3. The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to which the complainant is liable to pay.

Accordingly, the case is disposed of.

The opposite party is directed to submit the compliance report to this Forum within one month from the date of the issue of this order.
