GIST OF THE CASE

Tukaram Luha on behalf of Jayaram Sagar has appeared in the hearing on Dt. 20.09.2024 at Division Office, BNED and submitted a written complaint wherein he has stated that "he was living in his house since 2016 & paid the elenctic bill regularly. I was live in Dubai and my two brothers were lived in that house but they had not paid the electric bill & got electric connection in Soubhagya Scheme. Now I am facing difficulties in payment the electric bill as there is error in my bill" & has request to revise/rectify the bill.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has billing abstract from March-2001 to Aug 2024 but nor PVR or W/S has submitted in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD of 3KW with date of initial power supply on Dt.01.01.1990 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill.

Sri Tukarm Luha has attended the Forum's Camp at SDO, Brajarajnagar office on 20.09.2024 & submitted a written complain wherein he has stated that, he is presently staying in his father's house at Bagharachaka where the power supply in the name of his uncle (maternal) Sri Jayamangal Sagar. He started staying there since 2016 and two of his brother 1. Tusharkan Luha 2. Kulamani Luha were also staying there. His father has expired during 2020. His Uncle Sri Jayamangal Sagar also expired in 2020 (Approx). His Uncle Sri Jayamangal Sagar has never stayed in this house and was staying in a near by house at Bagharachaka and after his expiring his son 1. Minaketan Sagar is staying in this house now where the power supply is in the name of late Sri Jhasketan Singh alias Sagar who has also expired in about 2019. During scrutiny of the ledger/Samadhan App it came to the notice of the Forum that a meter SL No WCG22863 was effected in billing during Dec 2015 & continuing till date. Further, it is seen that PL/Avg bills were served to the complainant for the period from Feb-March 2001 to Feb-March 2004 & Aug 2008 to Nov 2015. To settle the billing dispute revision is required w.r.t Regulation 155 for the period from Dec 2013 to Nov 2015. He has prayed to divide the billed amount among him and his two brothers as well as consideration of bill revision as per law.

Lence, the opposite party is supposed to act as per the following direction to settle the billing dispute: -

I. As the power supply is in the name of Sri Jaymangal Singh who is now expired, his legal hairs are now liable to make this payments and hence, his prayer may not be consider for dividing the outstanding amount among brothers.

II. Revise the bill for the periods from Dec 2013 to Nov 2015 basing on the consumption recorded in meter Sl No WCG22863 taking IMR as '0' in Dec-2015 & FMR as 877 in May-2016 with the daily/monthly actual consumption thereof, w.r.to Regulation 155 considering the adjustment of previous bill revisions if any as per law.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- 1. the opposite party is supposed to act as per the following direction to settle the billing dispute:-
 - I. As the power supply is in the name of Sri Jaymangal Singh who is now expired, his legal hairs are now liable to make this payments and hence, his prayer may not be consider for dividing the outstanding amount among brothers.
 - II. Revise the bill for the periods from Dec 2013 to Nov 2015 basing on the consumption recorded in meter Sl No WCG22863 taking IMR as '0' in Dec-2015 & FMR as 877 in May-2016 with the daily/monthly actual consumption thereof, w.r.to Regulation 155 considering the adjustment of previous bill revisions if any as per law.
- 2. The Opposite party is directed not to consider the bill revision for the period revised earlier and adjust the revision as per law/for the period of penalty/in both cases, if any, as applicable as it has not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the benefits of OTS scheme and rebate thereof, if any, as applicable as it has not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, serve the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
