OPPOSITE PARTY

GIST OF THE CASE

The Complainant has filed the petition in the name of Tapeswar Sa bearing Consumer No 4172-2304-1154 under BNED, TPWODL, Brajrajnagar stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-domestic consumer having CD 2kw with initial date of p/s 20.04.2007 as seen from the FG data base/Samadhan App. The complainant has raised objection as mentioned in gist of the case. As seen, the meter bearing sl. no TPWODL1132694 was installed on 28.11.2022 with IMR as "0" and MF "1" and the old kwh was "3216" with reference to consumption recorded in meter bearing sl. no. "WLT212193" installed earlier. Actual bills were served upto billing month Aug'2015 with reference to consumption in meter sl. no. 8150743. The meter sl. no. 737618 seen in the billing since Mar'2007 upto Oct'2011. The meter sl. no. 8150743 might be installed during Nov-Dec'2011 but due to non-updating in billing data base the bills were not done in accordance to regulation. The meter sl. no.LW175166 was in billing dispute.

Hence, the Forum is in the opinion that the Opposite party is liable to revise the bill for the period from Nov'2011 to Aug'2015 considering the consumption recorded in meter sl. no. 8150743 taking IMR as "1" and the reading of "12866" kwh to be spread over in between the periods as well as for the period from May'2016 to Apr'2018 taking IMR as "1"kwh in Sep-Oct'2019 and FMR as "736"kwh Jan-Feb'2020 basing on the consumption recorded in meter sl. no.LW175166 with its daily/monthly actual average consumption thereof.

ORDER

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

- 1. The Opposite Party is directed to revise the bill of the complainant for the period from Nov'2011 to Aug'2015 considering the consumption recorded in meter sl. no. 8150743 taking IMR as "1" and the reading of "12866" kwh to be spread over in between the periods as well as for the period from May'2016 to Apr'2018 taking IMR as "1"kwh in Sep-Oct'2019 and FMR as "736"kwh Jan-Feb'2020 basing on the consumption recorded in meter sl. no.LW175166 with its daily/monthly actual average consumption thereof.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be. Accordingly, the case is disposed of.
