GIST OF THE CASE

The Complainant has filed the petition in the name of Pratap Kumar Mishra bearing Consumer No 4172-2306-0450 under BNED, TPWODL, Brajrajnagar stated about billing dispute-High meter reading even if house was closed regularly.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-domestic consumer having CD 2kw with initial date of p/s 01.07.2012 as seen from the FG data base/Samadhan App. The complainant has raised objection as mentioned in gist of the case. As seen, wrong billings have been done by opposite party from Dec'2021 to 10.07.2024. On 10.07.2024, the kwh reading was 11548 found ok. The opposite party has already been revised the bill from 08.12.2021 to 12.05.2023 for kwh reading of 6440 on 12.05.2023 and debited an amount of Rs 22,956.97/- after verification it is seen that the opposite party has already been revised the bill and hence bears no merit in this case for further revision.

Hence, the instant case petition is hereby dismissed.

Accordingly, the case is disposed of.
