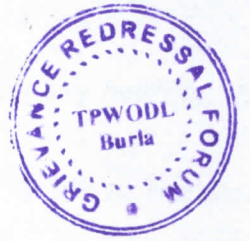

GIST OF THE CASE

The Complainant has filed the petition in the name of Fagu Pasayat bearing Consumer No **4172-2306-1107** represented by Hemakanta Pasayat under BNED, TPWODL, Brajrajnagar stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

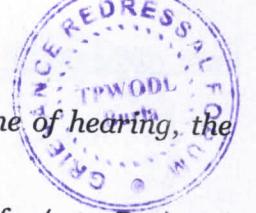
The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-domestic consumer having CD 2kw with initial date of p/s 07.11.2012 through meter sl. no. 637834 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. As seen, the meter sl. no LW300577 in billing since Jan-Feb'2021 with IMR as "o" and the meter sl. no. TWNX305224 was installed on 30.05.2024 with IMR as "o" and MF "1". In Sep-Oct'2016 and Nov-Dec'2016 the billing units were "7781" & "1348" with kwh reading 14872 and 13524. PL/Avg. bills were served from Jan-Feb'2017 to Dec'2020@1070/216 etc. monthly/bi-monthly. In such situation, bill revision is required to settle the billing dispute.

Hence, the Forum is in the opinion that the Opposite party is liable to revise the bill for the period from Date of p/s to Dec'2016 basing on the consumption recorded in meter sl. no. 637834 taking IMR as "1" kwh by spread over the kwh readings of 14872 in between the periods (1st) as well as spread over the kwh readings of 1758 in between the periods from Jan'2021 to Jun'2021 as per recorded consumption in meter sl. no. LW300577 (2nd) and revise the bill from Jan'2017 to Dec'2018 as per actual average consumption so derived in 2nd instance.

ORDER



Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

1. The Opposite Party is directed to revise the bill of the consumer the date of p/s to Dec'2016 basing on the consumption recorded in meter sl. no. 637834 taking IMR as "1" kwh by spread over the kwh readings of 14872 in between the periods (1st) as well as spread over the kwh readings of 1758 in between the periods from Jan'2021 to Jun'2021 as per recorded consumption in meter sl. no. LW300577 (2nd) and revise the bill from Jan'2017 to Dec'2018 as per actual average consumption so derived in 2nd instance.
 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
 7. **Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.**
- Accordingly, the case is disposed of.
