GIST OF THE CASE

The Complainant has filed the petition in the name of Bipin Bihari Dash bearing Consumer No 4171-2704-0502 under BNED, TPWODL, Brajrajnagar has stated about to change the tariff from GP to domestic.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted ledger copy for the period from Dec'2002 to Jan'2025, written statement, Field verification report by ESO, Lamtibahal and physical verification report on 24.03.2025 in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-GP consumer having CD 3.5kw with initial date of p/s 15.11.1997 as seen from the FG data base/Samadhan App. The complainant has raised objection as mentioned in gist of the case. After hearing from both parties, it is observed that:-

- The physical verification report submitted by opposite party states that the purpose of electricity used on date of verification is domestic.
- 2. In the physical verification report, field verification enquiry report and written statement equivocally states that the complainant uses the electricity for domestic purpose since many years probably from 2016 to till date. Therefore, taking regulation and natural justice into account the bill needs revision for change of tariff from GP to domestic.

ORDER

After careful consideration of hearing and data submitted by both parties, the Forum is pleased to pass the Order as follows:

 The Opposite Party is directed to revise the tariff of the complainant from 01.01.2016 and continue the same further accordingly. The DPS if any, so levied during the period should be waived out.

- 2. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustments for the payments made by the complainant.
- 3. The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to which the complainant is liable to pay.

The Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
