GIST OF THE CASE

The Complainant has filed the petition in the name of Saraswati Sisu Mandir bearing Consumer No 4170-0108-0311 represented by Nityananda Benia(Acharya)under BNED, TPWODL, Brajrajnagar has stated about billing dispute-In Oct'2024 the bill was suddenly high.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted photograph of the meter and PVR dtd. 02.01.2025 in this case.

OBSERVATION AND ORDER

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-SPP consumer having CD 2kw with initial date of p/s 09.07.2016 as seen from the FG data base/Samadhan App. The complainant has raised objection as mentioned in gist of the case. It is observed that:-

- Billing from Jul'2016 to Feb'2020 Actual and PL with the adjustment/revision of bill. So
 the billing is correct with meter sl. no.WUV11260.
- For the period from Mar'2020 to Jul'2021 PL bills with 81 units per month.
- In Aug'2021 the meter reading is 6398. So, 6398-3615=2783 with billed for Rs 16441.32 with revision of bill for the period from Mar'2020 to Jul'2021 with withdrawal an amount of Rs 8108.10/-.
- 4. From Dec'2022 to Jun'2023- X code i.e p/s disconnected with only fixed charge billing.
- 5. The meter reading is 11499kwh in Nov'2024.
- The meter reading is mor than 11578 kwh on 02.01.2025 as per PVR submitted by opposite party bill is correct.

Hence, there is no scope for bill revision so the instant case petition is hereby dismissed. Accordingly, the case is disposed of.
