## SUBMISSION OF OPPOSITE PARTY

## OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 3kw with initial date of p/s 01.01.1990 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. It is observed that the bill is ok. The complainant requests to test the meter and advised to deposit the testing fees. The opposite party has advised to receive the testing fees and test the meter as per clause no.226 of OERC Distribution (Conditions of Supply) Code,2019.

Hence, there is no scope for bill revision so the instant case petition is hereby dismissed.

Accordingly, the case is disposed of.
