GIST OF THE CASE

The Complainant has filed the petition in the name of Radheswari Bhoi bearing Consumer No 4172-1208-1406 under BNED, TPWODL, Brajrajnagar has stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted photograph of the meter and PVR dtd. 02.01.2025 in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 2kw with initial date of p/s 25.02.1999 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. PL bills were served from Jun-Jul'2002 to Apr-May'2003 but these bills have been adjusted/revised in Jul'2003 through meter sl. no.217586. From Jul'2003 to Sep-Oct'2011 bills are in actual reading is 8460 during Sep-Oct'2011 in meter sl. no.217586. From Nov-Dec'2011 to Oct'2020 bills PL/Avg.bills were served with 216 and other units. During Nov'2020 a meter was changed with meter sl. no.LW460265 and the meter is continuing till now. Hence, the Forum is in the opinion that there is no dispute in the bill and the bill is ok.

So, there is no scope of revision hence the instance case petition is hereby dismissed.

Accordingly, the case is disposed of.
