GIST OF THE CASE

The Complainant has filed the petition in the name of Tikeswar Chhatria bearing Consumer No 4172-1205-1637 under BNED, TPWODL, Brajrajnagar has stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted photograph of the meter and PVR dtd. 02.01.2025 in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 0.15kw with initial date of p/s 17.03.2010 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. Bills were served from May-Jun'2010 to Jan'2012 in actual with different units 63/100/50 units etc. Prov./Avg. bills from Mar-Apr'2012 to Oct-Nov'2019 with 136 units and others monthly/bi-monthly. During Jan'2020 meter was changed with new meter sl. no. LW439064. An amount of Rs 28610.95/- was in arrear till Apr'2024. From Apr'2024 p/s was disconnected. So, the complainant is advised to pay Rs 10000/- and opposite party is directed to reconnect the p/s after receiving of Rs 10000/-.

So, there is no scope of revision hence the instance case petition is hereby dismissed.

Accordingly, the case is disposed of.
