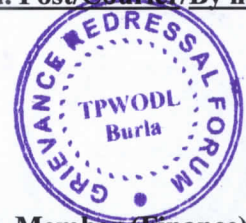

OPPOSITE PARTY

GIST OF THE CASE

Sri Subash Ch Podha bearing Consumer No 4162-3308-1181 is a domestic consumer with CD 0.5KW and date of supply release is 17.01.2019. He has submitted a written complain wherein he stated about billing dispute. Hence, he requests to revise/rectify the bill.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted the PVR carried on 12.01.2024 & no other documents have been submitted in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Dom consumer having CD 0.5kw with date of initial power supply 17.01.2019 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill & also expressed the displeasure. The meter SI No LW452982 was change on 01.01.2022 with IMR '0'. Actual bill was raised in Sept-2023 with KWh reading of 7029 with billing unit 1163 hence, billed for Rs.7091.02 & thereafter actual billing are going on with advanced reading in meter. The opposite party has already been revised the bill for the period from Jan 2022 to Aug 2023 (01.01.2022 to 14.09.2023) with KWh reading of 5866 on 14.09.2023 & debited an amount of Rs.26675.02 was correct. So, required bill revision for settlement of the billing dispute for other periods.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the period from 17.01.2019 (date of power supply) to Dec-2020 considering the recorded consumption in meter SI No LW452982 taking the IMR as '0' on 01.01.2022 and FMR as 5866 on 14.09.2023 with its daily/monthly actual average consumption.


ORDER


After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.


1. The Opposite Party is directed to revise the bill for the period from 17.01.2019 (date of power supply) to Dec-2020 considering the recorded consumption in meter SI No LW452982 taking the IMR as '0' on 01.01.2022 and FMR as 5866 on 14.09.2023 with its daily/monthly actual average consumption.

2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
7. **Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.**

Accordingly, the case is disposed of.
