GIST OF THE CASE

Sri Nitei Khamari on behalf of Balak Khamari appeared in the hearing on Dt. 13.03.2025 at the camp held at ESO Office, Panchgaon and submitted a written complaint wherein he has raised objection about supressed reading bill generated for the month of May-2024 & June-2024. Hence, the complainant prayed before the Forum to resolved the billing dispute accordingly.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party submitted the billing history from April-2018 to Feb-2025 & a copy of Physical Verification Report (PVR) carried out on Dt.09.03.2025 in this case.

OBSERVATION

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4172-2303-0174, having CD-2KW under LT-Domestic category, coming under ESO-Panchgaon & initial power supply effected on 01.01.1990.

This case was already registered vide Case No BRL/719/2024 received on 26.09.2024 and dismissed the same due to no merit. Now, the same case is registered again vide Case No BRL/113/2025 of Dt.13.03.2025 with same complainant.

The instance case petition is hereby dismissed, devoid of any merit.

Accordingly, the case is disposed of.
