GIST OF THE CASE

The Complainant has filed the petition in the name of Sri Durga Prasad Garnayak bearing Consumer No 4140-0103-1172 under DED, TPWODL, Deogarh stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider his case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted the ledger copy for the period from Jul'2017 to Dec'2023 in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-IPA consumer having CD 2.24kw with date of initial power supply 18.06.2017 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute where stated about collapsed of borewell since the date of dug same upto Feb'2023. In Mar'2023 the borewell was by cleared by the complainant himself and then the electric connection has been given. Again in Oct'2023 the borewell was collapsed and the complainant has intimated the same to concerned ESO, Budhapal and for that copy of letter on 28.03.2023 is enclosed for reference. The opposite party has asked to submit PVR alongwith w/s but failed to do so where the complainant has also asked to submit the report from OLIC, Deogarh but till date not submitted to this Forum. As observed no payment has been seen from the date of p/s to Dec'2023 and also seen the p/s has been effected without meter and average bills were served from the date of p/s to Jul'2023. Meanwhile, the meter sl. no."10044460" was installed on 04.09.2023 with IMR as" zero" and MF "1". The opposite party has done the bill revision for high units billed during TPWODL periods and withdrawn an amount of Rs 1000.37/-. In this connection, the Forum is thinking that there might be no use of p/s as the connection has not been given before Mar'2023 but also disbelieved on the collapsed of borewell since Oct'2023 as the new meter was installed during Sep'2023(04.09.2023) and billings are going on actual meter reading basis. To ascertain the correct material facts for decision making purpose a committee to be formed for submission of report.

Hence it is the opinion of the Forum that the opposite party is supposed to form the committee headed by EE,DED,Deogarh consisting of members like SDO,ESO,L/M,AOT,AOC etc. who have verified and inspect the material with field visit thereon in presence of the complainant and accordingly steps to be taken for revision of bills as per outcome of the report either to withdraw EC,ED



& DPS as per applicability from the billing for the periods was no p/s or otherwise revise the bill with reference to Reg.155 of OERC Distribution (Conditions of Supply)Code,2019.

ORDER

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

- 1. The Opposite Party is directed to form the committee headed by EE,DED,Deogarh consisting of members like SDO,ESO,L/M,AOT,AOC etc. who have verified and inspect the material with field visit thereon in presence of the complainant and accordingly steps to be taken for revision of bills as per outcome of the report either to withdraw EC,ED & DPS as per applicability from the billing for the periods was no p/s or otherwise revise the bill with reference to Reg.155 of OERC Distribution(Conditions of Supply)Code,2019.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.

Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.
