GIST OF THE CASE

Sri Krushna Chandra Barik appeared in the hearing on Dt. 13.03.2025 at the camp held at ESO Office, Panchgaon and submitted a written complaint wherein the complainant has raised objection about abnormal charging of bill particularly after installation of new meter for which the arrear amount was accumulated upto Rs.14330.00. Hence, the complainant prayed before the Forum to resolved the billing dispute accordingly.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party could submit photo of meter, billing history from Feb-2019 to Feb-2025 & a PVR caried out on Dt.10.03.2025 in this case.

OBSERVATION

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4170-0103-3436, having CD- 3HP under LT-Irrigation Pumping & Agriculture category, coming under ESO-Panchgaon & initial power supply effected on 14.08.2018. On scrutinizing the records in detail, the Forum observed that 1st bill was generated in Feb-2019 on average basis and the same average bill continued up to July-2022 and provisional bill continues from Aug-2022 to Nov-2024. A new meter bearing Sl No "TWSC10070119" has been installed on 09.01.2025, replacing the old meter No "WM469124" with FMR as '8930.06' during Dec-2024 & actual bill was raised with '9242' units considering the old meter consumption as '8930.06' units & the current meter CMR as '312' KWh. Hence, the Forum construed that the excess billing so charged in Dec-2024 is to be spread over from date of installation of old meter (old meter no-WM469124) there by revising the previous (average/provisional) billing from date of installation of old meter.

ORDER

After careful consideration of hearing and documents, statements available on records, the Forum hereby passes order in consonance with Regulation of OERC Distribution (Conditions of Supply), Code,2019

1. The Opposite Party is directed to revise the energy bills from 14.08.2018 to Nov-2024 by recasting the accumulated reading of "8930.06" KWh (as recorded in old meter No "WM469124") on monthly average basis, from the date/month of installation of the same, duly adjusting the bill revision made earlier and/or, the benefit arising out of the OTS Scheme, if any.

- 2. The Opposite Party is directed to revise the energy bill for Dec-2024 as per actual meter reading of meter No TWSC10070119, duly adjusting the bill revision made earlier and/or, the benefit arising out of the OTS Scheme, if any.
- 3. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant
- 4. The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to which the complainant is liable to pay.

Accordingly, the case is disposed of.

The Opposite Party is directed to submit the compliance report to this Forum within one month from the date of the issue of this order
