GIST OF THE CASE

The Complainant has filed the petition in the name of Brajalal Nayak bearing Consumer No 4163-3532-0050 under SEED, TPWODL, Sambalpur has objected about abnormal excess bill charged but could not emphatically mention the period of billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Dom consumer having CD 0.70kw with initial date of p/s 01.01.1990 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. After hearing from both parties, it is observed that there was a bill revision on 15.02.2025 and Rs 9849.94/- has been debited(added) to the consumer account for defective period assessment from Nov'2021 to Oct'2023. Provisional bills were served to the complainant from Nov'2021 to Oct'2023 with meter sl. no. "LW625178" which was defective with the reading of 927kwh throughout. During Nov'2023, a new meter sl.no. "TWSP51072050" was installed and the above provisional bills been revised as per the average of six months reading in the newly installed meter no. "TWSP51072050" as per clause 155 of OERC Distribution (Conditions of Supply) Code,2019. The bill so charged is found to be genuine and there is no merit in the petition filed.

Hence, the instant case petition is hereby dismissed.

Accordingly, the case is disposed of.
