



GIST OF THE CASE

The Complainant has filed the petition in the name of Krushna Chandra Tripathy bearing Consumer No **4160-0103-1004** under SEED, TPWODL, Sambalpur has stated about billing dispute, Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents except consumer history for the period from Jul'2018 to Feb'2025 in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Irrigation Pumping and Agriculture consumer having CD 3kw with initial date of p/s 02.02.2024 as seen from the FG data base/ Samadhan App. The complainant has raised objection as mentioned in gist of the case. After hearing from both parties, it is observed that:-

1. Average/Provisional bills charged for the period from Apr'2018 to Aug'2024 with various units like '500','0' etc though the status in FG shows U/MU/IDF/D/N code etc without meter as per samadhan app.
2. A new meter was installed on 21.09.2024 with meter sl. no."TWSC59004947" (IMR as "0") and old meter with sl. no."WM290237" without meter reading.
3. Average consumption to be evaluated as per the new meter consumption (1471+83+88+111+153+March consumption to be noted/6 months to be calculated) and the bills are to be revised as per clause 155 of OERC Distribution (Conditions of Supply) Code,2019.

Hence, the Forum construed that the opposite party is required to revise the bills charged upto and including two years prior to installation of meter sl. no."TWSC59004947" on the basis of succeeding six months actual monthly average consumption from the date/month of installation of the same *as per regulation 155 of OERC Distribution (Conditions of Supply) Code,2019.*

ORDER

After careful consideration of hearing and data submitted by both parties, the Forum is pleased to pass the Order as follows:

1. The Opposite Party is directed to revise the bill charged upto and including two years prior to installation of meter sl. no. "TWSC59004947" on the basis of succeeding six months actual monthly average consumption from the date/month of installation of the same as per regulation 155 of OERC Distribution (Conditions of Supply) Code, 2019.
2. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustments for the payments made by the complainant.
3. The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to which the complainant is liable to pay.

Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.


