GIST OF THE CASE

Sri Tuleswar Pradhan appeared in the hearing on Dt. 20.03.2025 at the camp held at SDO Office, Belpahar and submitted a written complaint wherein the complainant has raised objection about abnormal excess bill charged during the year 2001 to 2024. Hence, the complainant prayed before the Forum to resolved the billing dispute accordingly.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party could submit billing history from May-2013 to Nov-2024 in this case.

OBSERVATION

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4172-2207-1682, having CD-2KW under LT-Domestic category, coming under ESO-Belpahar & initial power supply effected on 01.05.2013.

From scrutiny of billing data from FG (licensee soft records) database, the Forum observed that penal assessment was done by the opposite party in two separate eccasion occasions, inspected on 01.04.2024 & 09.11.2024 due to theft of energy and was later settled by the complainant. It was further noticed that the energy bills charged from Sept-2021 to July-2022 were revised by the opposite party and Rs.34230.35/- was debited (added) to the consumer account, effected in billing on 30.09.2023, due to delayed meter updation and based on comparison of defective meter period assessment already done with respect to the new meter average consumption recorded after installation of the same.

On scrutinizing the records in detail, the Forum construed that the additional energy bill so charged in Aug-2023 amounting to Rs.34230.35/- is found to be legitimately charged as per Regulation-155 of OERC Distribution (Conditions of Supply) Code,2019 and hence, there is no further scope for revision of such bill charged.

Hence, the instance case petition is hereby dismissed, devoid of any merit.

Accordingly, the case is disposed of.
