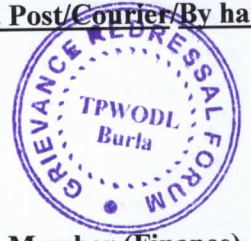

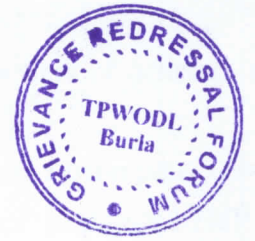

GIST OF THE CASE

The Complainant has filed the petition in the name of Sub-Centre Building C/o-Smt. Susama Sahu bearing Consumer No **4141-1501-0419** under DED, TPWODL, Deogarh stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider his case for revision/rectification.


SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted the ledger copy for the period from Nov'2008 to Dec'2023 and not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-SPP consumer having CD 0.50kw with initial date of p/s 28.09.2008 as seen from the FG data base. The meter sl. no."300001271" was installed on 13.07.2023 with IMR as "zero" and MF "1" with old kwh reading of "12420" with reference to meter sl. no."6678422" was installed earlier. The above complainant was served Actual/PL bills were served in reference to consumption recorded in meter sl. no. "6678422" was effected in billing since the date of p/s with adjustment of PL amount but billed for units of 1570/3700 with kwh reading of 6500/10200 in the month of Oc-Nov'2012/Oct-Nov'2013 respectively. Actual bills also have been done since 12.01.2014 to 06.07.2014 with high units of billing as 1000/258/442/520 with kwh reading of 11200/11458/11900/12420 respectively during the above periods. PL/Avg. bills were served with Aug-Sep'2014 to May'2023 at present actual billing with taking meter reading of new meter are going on. So, for settlement of the dispute bill revision is required.

Hence, the Forum is in the opinion that the Opposite party is liable to revise the bill for the period from 28.09.2008 to Jul'2014 basing on the consumption recorded in meter sl. no." 6678422" taking the IMR as "zero" kwh by spread over the reading of "12420" in between the periods as well as for the period from Feb'2019 to Jan'2021 basing on the consumption recorded in meter sl. no. "300001271" taking IMR as "182" kwh in Dec'2023 and FMR as "the recorded reading in May'2024" and the daily/monthly actual average consumption thereof.


ORDER


Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:


1. The Opposite Party is directed to revise the bill of the consumer for the period from 28.09.2008 to Jul'2014 basing on the consumption recorded in meter sl. no." 6678422" taking the IMR as "zero" kwh by spread over the reading of "12420" in between the periods as well as for the period from Feb'2019 to Jan'2021 basing on the consumption recorded in meter sl. no. "300001271" taking IMR as "182" kwh in Dec'2023 and FMR as "the recorded reading in May'2024" and the daily/monthly actual average consumption thereof.
2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
7. **Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.**

Accordingly, the case is disposed of.
