

## GIST OF THE CASE

The Complainant has filed the petition in the name of Sri Kedar Dharua S/o Late Kushal Dharua bearing Consumer No 4141-1589-0478 under DED, TPWODL, Deogarh stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider his case for revision/rectification.

#### SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted the ledger copy for the period from Apr'2010 to Dec'2023 and not submitted any relevant documents in this case.

#### **OBSERVATION**

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-domestic consumer having CD 0.11kw with initial date of p/s 08.04.2010 through meter sl no."808812" as seen from the FG data base. The above complainant was served actual. Bill in Sep'2015 with kwh reading of "1295" and in Sep'2016 for kwh reading of "207" with billing unit "8912" and seen that the meter was completed the round hence the billing has developed in a such a manner where found the total consumption from 08.04.2010 to Sep'2016 for "10207" units during the above periods. The meter sl. no."LW321520" was effected in billing in Sep'2019 with advance reading there on time to time with IMR as "1". PL/Avg. bills were served from Feb-Mar'2017 to Jun-Jul'2019.So, for settlement of the dispute bill revision is required.

Hence, the Forum is in the opinion that the Opposite party is liable to revise the bill for the period from Aug'2017 to Jul'2019 basing on the consumption recorded in meter sl. no." LW321520" taking the IMR as "48" kwh in Dec-Jan'2020 and FMR as "96"kwh in Apr-May'2020 as well as by spread over the reading of "10207" in between the periods from 08.04.2010 to Sep'2016 basing on the consumption recorded in meter sl. no. "808812" and the daily/monthly actual average consumption thereof.

### **ORDER**

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

- 1. The Opposite Party is directed to revise the bill of the consumer for the period from Aug'2017 to Jul'2019 basing on the consumption recorded in meter sl. no." LW321520" taking the IMR as "48" kwh in Dec-Jan'2020 and FMR as "96"kwh in Apr-May'2020 as well as by spread over the reading of "10207" in between the periods from 08.04.2010 to Sep'2016 basing on the consumption recorded in meter sl. no. "808812" and the daily/monthly actual average consumption thereof.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.

 Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
