GIST OF THE CASE

Sri Hemanta Patra son in law of Late Balaram Padhan (consumer) appeared in the hearing on Dt. 20.03.2025 at the camp held at SDO Office, Belpahar and submitted a written complaint wherein the complainant has raised objection about high average billing. Hence, the complainant prayed before the Forum to resolved the billing dispute accordingly.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party submitted billing history from May-2003 to Feb-2025, a Physical Verification Report carried out on 03.04.2025 & photocopy of meter photo in this case.

OBSERVATION

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4172-1205-3971, having CD-2KW under LT-Domestic category, coming under ESO-Belpahar & initial power supply effected on 06.12.2001.

On scrutinizing the records in detail, the Forum observed that there is average billing from Sept-2003 to Dec-2018. A new meter bearing Sl No "LW056165" was installed during Dec-2018 and thereafter the billing is continuing in actual basis. It is seen that there is average billing at higher units of consumption/month than the actual monthly consumption recorded in the newly installed meter. The bill may be revised as per Regulation 155 of OERC Distribution (Conditions of Supply), Code,2019.

ORDER

After careful consideration of hearing and documents, statements available on records, the Forum hereby passes order in consonance with Regulation of OERC Distribution (Conditions of Supply), Code, 2019

- 1. The Opposite Party is directed to revise the energy bills charged from Jan-2016 to Dec-2018as per succeeding six months average consumption recorded in new meter Sl No "LW056165" during Dec-2018, duly adjusting the bill revision made earlier and/or, the benefit arising out of the OTS Scheme, if any.
- The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant
- 3. The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to which the complainant is liable to pay.

Accordingly, the case is disposed of.

The Opposite Party is directed to submit the compliance report to this Forum within one month from the date of the issue of this order.
