GIST OF THE CASE

Kumodini Padhan (daughter of the consumer) on behalf of consumer Bhima Pradhan who appeared on Dt. 26.02.2024 at camp held at See Office Belpahar and submitted a written complaint wherein she has stated about billing dispute & request to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted bill abstract of the consumer from March-2001 to July-2023. No PVR or W/S has been submitted in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 1KW with date of initial power supply 01.01.1990 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. The complainant has been served actual/PL bills with adjustment of PL billing since Aug-2016 to Jan-2023 and found LD from Feb-2023 to July-2023 and no billing has been seen since Aug-2023. Further, LD has been seen for the period from March-2009 to July-2016 where found only in March 2009 FC was levied but no fixed charge was included in billing from April-2009 to July-2016. Meanwhile, the meter Sl No 173855 was effected in billing in April-May-2002 where it is seen that the KWh reading of 13669 in Sept-2018 with IMR '1' with billing unit 13140 & also found that PL/Avg bills were served from Oct-Nov-2002 to Aug-2008. Hence, revision is required to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from April-May-2002 to Sept-2008 by spread over the reading of 13669 units with IMR '1' in reference to consumption recorded meter SI No 173855 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any and for the period from Feb-March-2001 to Feb-2002 as per daily/monthly actual consumption so derived in earlier revision as mentioned here but after conducting physical verification & reporting thereon and if found any deviation to be taken care in accordance to law/regulation.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- 1. The Opposite Party is directed to revise the bill for the periods from April-May-2002 to Sept-2008 by spread over the reading of 13669 units with IMR '1' in reference to consumption recorded meter Sl No 173855 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any and for the period from Feb-March-2001 to Feb-2002 as per daily/monthly actual consumption so derived in earlier revision as mentioned here but after conducting physical verification & reporting thereon and if found any deviation to be taken care in accordance to law/regulation.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- The Opposite party is directed not to consider the bill revision for the period already where the complainant
 has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for
 the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- The Opposite Party is directed to collect the revised bill amount and on non-payment, served the
 Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and
 disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
