GIST OF THE CASE

Abina Ku Sahu appeared on Dt. 26.02.2024 at camp held at SDO Office Belpahar and submitted a written complaint wherein he has stated about billing dispute & request to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted bill abstract of the consumer from Dec-2020 to Jan-2024. No PVR or W/S has been submitted in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 0.5KW with date of initial power supply 11.12.2018 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter Sl No 5343301 & LW655957 was installed on 10.12.2018 & 06.05.2023 with IMR '0' & MF 1 each with old meter reading of 1586KWh in billing month June 2021 & the complainant has been served PL/Ave bill from July 2021 to March -2023 where found the new meter was changed & reflected in billing in April 2023. Although the meter SL No LW655957 was replaced in place of old meter on 20.09.2021 as per the records maintained by ESO & SDO office but reflected in billing in April-2023 with the date as 06.05.2023 which was treated as wrong. In this regard, the SDO, Belpahar has been taken into confidence & asked to submit the meter installation protocol but not yet submitted. Hence, revision is required to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from 20.09.2021 to 06.05.2023 by spread over the reading of 2244 units as seen from the billing data with IMR '0' in reference to consumption recorded meter Sl No LW655957 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any but after conducting physical verification & reporting thereon and if found any deviation to be taken care in accordance to law/regulation and going through the meter protocol report also.

ORDER

Ifter careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- 1. The Opposite Party is directed to revise the bill for the periods from 20.09.2021 to 06.05.2023 by spread over the reading of 2244 units as seen from the billing data with IMR '0' in reference to consumption recorded meter Sl No LW655957 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any but after conducting physical verification & reporting thereon and if found any deviation to be taken care in accordance to law/regulation and going through the meter protocol report also.
- The Opposite party is directed not to consider the bill revision for the period already revised earlier/for 2. the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.
