OPPOSITE PARTY

GIST OF THE CASE

Bishnu Rout (Father of the consumer) on behalf of Sanatan Rout (consumer) who appeared on Dt. 26.02.2024 at camp held at SDO Office Belpahar and submitted a written complaint wherein he has stated about billing dispute & request to revise/rectify the same and reconnect the power supply.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted bill abstract of the consumer from Dec-2002 to July-2023. No PVR or W/S has been submitted in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 2KW with date of initial power supply 31.03.2002 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. The complainant has been served actual bill in Dec-2020 with KWh reading of 12922 & PL bill from Jan-2021 to July-2023. The billing status mentioned as bill stopped since Aug-2023 to till date. The outstanding amount in Dec-2020 was Rs.12414.82. During course of hearing the complainant has stated that the power supply is required for use hence considered the reconnection of the above disconnected consumer. In presence of opposite party, the complainant has agreed to pay Rs.12000.00 where the opposite party has also agreed on the same subject to revisions of bills in later stage. Keeping the commitment, the complainant has paid of Rs.12000.00 on 26.02.2024 immediately on the camp day. In course of hearing the complainant has stated that the power supply was in LD position from Jan-2021 to July-2023 for which both parties have yet not submitted any documentary evidence so, the Forum not prefers to pass any order in absence of any documents in support of LD as required as per regulation. However, taking the hearing & claim of the complainant, the opposite party is supposed to steps forwards for its enquiry for giving opportunity to the complainant with in the purview of law.

Hence it is the opinion of the Forum that the opposite party is liable to reconnect the power supply immediately as the complainant has already been paid the committed amount of Rs.12000.00 on 26.02.2024. Further, to confirm the LD periods & its revision, a committee to be formed headed by Executive Engineer consisting of SDO, ESO, AOT, AOC & line man who are conduct the enquiry and submit the report & as per outcome of the report the bill revision to be done by opposite party with reference to law/regulation.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- 1. The Opposite Party is directed to to reconnect the power supply immediately as the complainant has already been paid the committed amount of Rs.12000.00 on 26.02.2024. Further, to confirm the LD periods & its revision, a committee to be formed headed by Executive Engineer consisting of SDO, ESO, AOT, AOC & line man who are conduct the enquiry and submit the report & as per outcome of the report the bill revision to be done by opposite party with reference to law/regulation.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- The Opposite party is directed not to consider the bill revision for the period already where the complainant
 has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for
 the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
