GIST OF THE CASE

Smt Manju Nanda on behalf of Rameswar Nanda appeared in the hearing on Dt. 07.04.2025 at the camp held at ESO Office, Chipilima and submitted a written complaint wherein she has stated that due to wrong billing there is much arrear against the consumer and supply has been disconnected due to nonpayment. She has request for revision of bill & restore of power supply against payment of Rs.2000.00/- only as her husband is bedridden and power supply is necessary for him.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party submitted billing abstract from April-2018 to March-2025, a Physical verification Report carried out on Dt. 17.04.2025 & written statement in this case. In reply to the case the opposite party submitted the following facts.

- The consumer received incorrect bills on the following average/provisional consumption:-
 - 864 units/provisional (June-2015 to Jan-2016)
 - 1728 units (Feb-2016 to Sept-2016)
 - 864 units (Oct-2016 to Sept-2017)
- 2. A new meter "WLT037352" changed on Sept-2017.
- The Opposite Party suggested that bill from June-2015 to Sept-2017 based on the actual average consumption of meter No "WLT037352", calculated from Oct-2017 (IMR-113) to March-2018 (FMR).

OBSERVATION

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4118-3104-0056, having CD-2KW under LT-Domestic category, coming under ESO-Chipilima & initial power supply effected on 01.01.1990. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

1. Provisional/average bills charged from June-2015 to Jan-2016 @ 864 units/bimonthly.



2016 to Aug-2017 @ 864 units/monthly. Sept-2017 bill was charged on actual basis as per consumption recorded in new meter No "WLT037352" installed & updated during Sept-2017.

Hence, it is construed that, the bills are to be revised from Oct-2015 to Sept-2017 as per clause-155 of OERC Distribution (Conditions of Supply), Code, 2019, subsequent to installation of meter No "WLT037352" during Sept-2017.

ORDER

After careful consideration of hearing and documents, statements available on records, the Forum hereby passes order in consonance with Regulation of OERC Distribution (Conditions of Supply), Code, 2019

- 1. The Opposite Party is directed to revise the energy bills charged from Oct-2015 to Sept-2017 on the basis of succeeding six months average consumption with meter No "WLT037352" installed during Sept-2017, duly adjusting the bill revision made earlier and/or, the benefit arising out of the OTS Scheme, if any.
- 2. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant
- 3. The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to which the complainant is liable to pay.

Accordingly, the case is disposed of.

The Opposite Party is directed to submit the compliance report to this Forum within one month from the date of the issue of this order
