GIST OF THE CASE

The Complainant filed the petition in the name of Sri Bijoy Meher bearing Consumer No 4172-2303-2053 under BNED, TPWODL, Brajrajnagar stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted ledger copy for the period from Aug'2017 to Jan'2024 in this case.

OBSERVATION

The case is pursued with all documents available in record and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-GP consumer having CD 3kw as seen from the FG data base/Samadhan App. The complainant has been raised objection on billing dispute and pray for its revision. The complainant has stated that there was no use of p/s since years but electric bills were generated accordingly. In this regard, the opposite party has not submitted anything except ledger copy and bill where mentioned that not to be distributed to consumer with outstanding amount of Rs 48,600/- for the month of Dec'2023. In the absence of documentary evidence from opposite party and reliable clarification from complainant about date/month/year of non-use of p/s it is difficult to ascertain on the consumption/non-consumption of electricity by the complainant. To resolved the billing dispute, the opposite party will take adequate steps to make enquiry by forming an enquiry committee headed by EE consisting of concerned SDO,ESO,AOT,AOC & L/M who will investigate the matter and as per outcome of the enquiry necessary action to be taken by opposite party for bill revision with reference to law to settle the billing dispute and due to which the grievance of the complainant can be resolved.

ORDER

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

1. The Opposite Party is directed to take adequate steps to make enquiry by forming an enquiry committee headed by EE consisting of concerned SDO,ESO,AOT,AOC & L/M who will investigate the matter and as per outcome of the enquiry necessary action to be taken accordingly for bill revision with reference to law to settle the billing dispute.

- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
