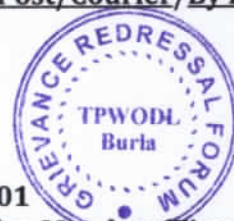


OPPOSITE PARTY
