GIST OF THE CASE

Sri Satyabadi Pradhan appeared in the hearing on Dt. 18.04.2025 at the camp held at ESO Office, Naktideol. The Complainant filed the petition disputed about the abnormal bill raised particularly during the replacement of old meter. Hence, the Complainant prayed before the Forum to direct the Opposite Party to resolve the billing disputes accordingly.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from Dec-2021 to March-2025, a Physical Verification Report carried out on Dt.23.04.2025, meter photo, Photocopy of meter replacement report & a consumer information sheet in this case.

OBSERVATION

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4164-3302-3475, having CD-0.50KW under LT-Domestic category, coming under ESO-Naktideol & initial power supply effected on 15.11.2021. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- 1. That, on examining the case in detail, the Forum observed from the records that during March-2024, actual bill of 302 units were charged, considering the initial reading of KWH "000147" and current reading of KWH"00449", recorded in meter SL. No. "WHL012730". The Opposite Party certified that the same meter was changed with a new meter No "TWST1714896", due to error code showing in the old meter as "UEr449.02". However, KWH"00449" was wrongly entered in billing as current reading for the month which led to charging of Rs.1535.99/- with "302" units charged for the month.
- 2. It was observed from records that a new meter No" TWST1714896" was installed in the premises on 21-May-2024.

3. The ledger abstract also revealed that the energy bills charged from December-2021 to March-2024 have been revised by the Opposite Party and Rs. 552.42/- was given credit effect to the complainant's ledger on 24.04.2024, which covers the abnormal bill previously charged in March-2024. Actual bills have been continuing since May-2024 onwards and there is no further scope for revision to this effect.

The instant case is hereby dismissed devoid of any merit.

Accordingly, the case is disposed of.
