GIST OF THE CASE

Sri Mohan Meher on behalf of Madhu Meher appeared in the hearing on Dt. 22.04.2025 at the camp held at ESO Office, Panchgaon. The Complainant filed the petition disputed about abnormal excess bills charged particularly for six to eight months from July-2022 onwards. Hence, the Complainant prayed before the Forum to consider his grievances sympathetically and direct the Opposite Party to resolve the billing disputes accordingly.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from Jan-2021 to March-2025 & a Physical Verification Report carried out on Dt.15.04.2025 in this case.

OBSERVATION

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4172-2303-0083, having CD-5.50KW under LT-Domestic category, coming under ESO-Panchgaon & initial power supply effected on 02.03.2002. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- 1. That, on examining the case in detail, the Forum observed from the records that provisional and average bills were previously charged from September-2021 to November-2023 on different units from time to time.
- 2. That, a new meter SL. No. "TWNX512991" installed in the premises on 21.12.2023 and actual bills continued thereafter till last billing. The Physical Verification Report. dtd,15.04.2025 indicated that the same meter has been found in running condition with advanced meter reading recorded as KWH "004682".
- 3. That, no average bills were revised by the Opposite Party from September-2021 to November-2023 in earlier occasions. The Opposite Party could not submit the written reply in support of their views to the case along with other relevant documents.

President Grævance Redressal Forum TPWODL, Burla - 768017 The Forum on scrutinizing the records, reports available on record, construed that the provisional/average bills charged from September-2021 to November-2023 are to be revised by the Opposite Party, limited to two years, as per Regulation 155 of OERC Distribution (Condition of Supply), Code, 2019.

ORDER

After careful consideration of hearing and documents, statements available on records, the Forum hereby passes order in consonance with Regulation of OERC Distribution (Conditions of Supply), Code, 2019

- 1. The Opposite Party is directed to revise the energy bill charged in December-2021 to November-2023, on the basis of succeeding six months actual monthly average consumption recorded in meter No "TWNX512991", from the date/month of installation of the same, duly adjusting the bill revision made earlier and/or the benefit arising out of the OTS Scheme, if any.
- 2. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant
- 3. The Complainant is directed to pay the revised billed amount so arrived at, if any, within due date after receipt of the revised energy charges bill to which the complainant is liable to pay.

Accordingly, the case is disposed of.

The Opposite Party is directed to submit the compliance report to this Forum within one month from the date of the issue of this order.
