OPPOSITE PARTY

GIST OF THE CASE

1. Shyam Narayan Pattanayak appeared on Dt. 15.02.2024 at the camp held on ESO Office Gosala and submitted a written complaint wherein he has stated that the consumer number 4118-3306-0061 is in the name of his Late father Nabin Kishor Pattanayak and being used by him at present. He along with his father have ben using this power supply for domestic purpose with his front room being used as cycle repairing shop which is commercial in nature.

His tariff has been listed as commercial for the whole load of CD 1KW since the date of power supply and he has been billed as G.P consumer since beginning. His father has been written many applications requesting change of tariff from Commercial to Domestic. Sri Shyam Pattanayak has submitted copies of 02 No of application signed by his late father Nabin Kishor Pattanayak on Dt.10.10.2006 & 11.02.2012 addressed to the ESO, Gosala, WESCO wherein he has requested to change the tariff from Commercial to Domestic.

2. Sri Pattanayak in his application Dt. 15.02.2024 has stated that his tariff has already been changed to Domestic from G.P by the present incumbent ESO Sri Niroj Sahu on 09.02.2024. The complainant has requested this Forum to revise the outstanding amount of Rs.456000.00 from Jan 2021 at least i.e from the date of taking over by TPWODL.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted a copy of PVR of the consumer made on 08.02.2024 wherein the opposite has stated that "the consumer is availing power supply of 0.778KW load for domestic purpose out of which 0.12KW load is used for commercial purpose in front of house which is with in 20% of the total load. Hence the tariff is to change from General Purpose to Domestic."

OBSERVATION

From the statement & documents submitted by both the parties this Forum observed that as the consumer is using 02 Nos of Bulb points of 9W LED bulbs and 01 No of Fan in the front room where there is a cycle Repairing shop the present load is 0.12KW, which is within 20% of contract demand of 01KW. The consumer has also stated during hearing that he has been using these LED bulbs from before 2021 and hence he requests to revise the tariff grom G.P to Domestic from Jan 2021 is justified. As there are 02 Nos of bulb points, earlier he might have used incandescent bulbs of about 100W each to haling the load to more than 20% of C.D and hence the tariff of earlier period without LED bulbs is justified to be G.P.

ORDER

After careful examination of the statements & documents submitted, this Forum is pleased to pass the Order as follows.

- 1. The Opposite Party is directed to revise the bill by taking the total load as Domestic in place of G.P from 01.01.2021 till date and serve a revised bill to consumer.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- The Opposite party is directed not to consider the bill revision for the period already where the complainant
 has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for
 the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
