## **GIST OF THE CASE**

Sri Jaishankar Singh appeared in the hearing on Dt. 17.06.2025 at the camp held at SDO Office, Hirakud. The Complainant filed the petition objected that no new service connection was released that was applied in the name of his son Sri Prakash Singh, on the ground of existing electricity arrear pending against the complainant. Hence, the Complainant prayed before the Forum to direct the Opposite Party to resolve the disputes and extend new power supply accordingly.

## **SUBMISSION OF OPPOSITE PARTY**

The opposite party not submitted any relevant documents in this case.

## **OBSERVATION**

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4118-3411-0222, having CD-1KW under LT-Domestic category, coming under ESO-Hirakud & initial power supply effected on 27.07.2013. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- 1. That, as per objection raised by the complainant and on examining the case in detail, the Forum observed from the billing records that provisional bills that were charged intermittently upto December-2022 billing, were properly adjusted in subsequent billing months as per advanced consumption recorded in the existing meter No"8158268", that has been available in the premises since the date of initial power supply.
- 2. That, the current arrear outstanding as of May-2025 stood at Rs. 112594.89/-.
- 3. That, regulation 17(i) of OERC Distribution(Condition of Supply)Code,2019 clearly envisaged that if the applicant in respect of an earlier agreement executed in his/her name or in the name of his spouse, son, daughter, parents, is in arrears of electricity dues or other dues for the same premises or his/her other premises situated in the same DISCOM or any other DISCOM in the State, the application for supply shall not be allowed by the engineer until the arrears are settled and paid in full.

- 4. That, any application for new service connection shall be accompanied by an undertaking through affidavit that, the applicant has no outstanding dues payable to the present distribution licensee/supplier or any other distribution licensee/supplier within the state of Odisha as specified in Form 1 & 2 of the application form for new power supp
- 5. That, there is no further scope of revision of earlier bills charged against the existing domestic connection.
- 6. he Forum on scrutinizing the records, reports available on record, construed that since the electricity arrear is still pending against the existing connection of the complainant, the application for new power supply in the name of his son cannot be entertained until the arrears are settled and paid in full.

Hence, the instant case is hereby dismissed, devoid of any merit.

Accordingly, the case is disposed of.
