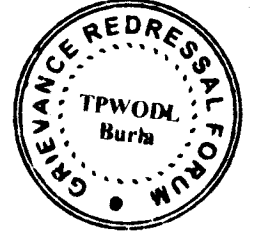

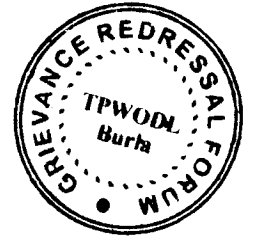


OPPOSITE PARTY
