GIST OF THE CASE

Sri Milan Kumar Behera appeared before this forum on dated 17th of November 2023 at its camp held in the office of SDO-II Jharsuguda and submitted a written complaint wherein he has stated that "After written application to SDO, Jharsuga-II the meter was fitted in the month of Dec-2021 & electric bill was paid as per new meter consumption. After that an arrear bill was generated in the month of Feb-2023." So, he has requested to consider his matter & revise the bill as he was a regular electric bill paying consumer.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is persued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-Dom consumer having CD 3kw with date of initial power supply 14.03.2002 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill & also expressed the displeasure. PL/Avg bills were served to the complainant from 14.03.2002 to Dec-2003 & Feb-2019 to Oct-2021. The opposite party has done the bill revision for 02years (Nov-2019 to Oct-2021) with reference to Regulation 155 where it is seen that an amount of Rs.41272.75 has already been added (debited) in billing seems to be correct & the opposite party is liable to pay the same to the opposite party. During course of hearing the complainant has convinced but prayed for allow of instalments to clear the dues.

Hence, the instant case petition is hereby dismissed as the opposite party has revised the bill with reference to Regulation 155 & no merit in the case but directed to the opposite party to allow suitable instalments on application for the same so that the complainant will able to clear the dues.

Accordingly, the case is disposed of.
