GIST OF THE CASE

Sri Balgobinda Beriha appeared before this forum on 06.01.2024 at its camp held in the office of ESO Commissioner colony and submitted a written complaint wherein he has stated that his bill is coming in higher side and hence he prays to revise the bill.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted the consumer information sheet and ledger abstract From April-2007 to April-2021 from Samdhan App & ledger abstract from April-2018 to Nov-2023 from FG..

OBSERVATION

From the records this forum observes that the initial date of power supply is 22.09. 1999.Bill from April-2007 to July-2016 have been served on actual basis. Bill from Aug-2016 to May-2019 have been served on PL/Avg basis with 312 units. There was a change of meter on 15.05.2017 with meter Sl No WLT002425, make L&T after which his consumption has been recorded as 189, 145, 159, 151, 97, 123 units for the next 6 consecutive months with average if 144 units.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- 1. The opposite party is directed to revise the bill from Aug-2016 billing month up to May-2017 billing months by withdrawing the AV/Pl units of 372/month by putting 144 units/month.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.

The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.

- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
