GIST OF THE CASE

The Complainant filed the petition in the name of Alok Kumar Sahu bearing Consumer No **4130- 0101-1563** under JED, TPWODL, Jharsuguda stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents except PVR dtd. 23.04.2024 in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-domestic consumer having CD 5kw with initial date of p/s o8.08.2017 and meter sl. no."2971468" was in billing since Nov'2019 as seen from the FG data base/Samadhan App. The complainant has raised objection on billing dispute. LD has been seen since Jul'2022 to May'2023. The above complainant was served actual bills in Jun'2022 for kwh reading of "26465" and in Jun'2023 for kwh reading of "30837" with reference to consumption recorded in meter sl. no."2971468". This Forum has gone through PVR dtd. 23.04.2024 of ESO,Bagdihi and SDO,Jharsuguda where found the complainant has also signed here. As per PVR, the complainant was never LD during Aug'2022 to Jun'2023 and it was wrongly shown as disconnection in the system and accordingly the complainant has availed the p/s during the above periods. During the course of hearing, the complainant has been asked and from the reply it was cleared that the complainant was used the p/s during the above periods and also agreed and acknowledged the PVR. The consumptions were high units of billing and supressed readings were billed time to time seems to be improper. So, for settlement of the dispute bill revision is required.

Hence, the Forum is in the opinion that the Opposite party is liable to revise the bill for the period from Nov'2019 to 23.04.2023 basing on the consumption recorded in meter sl. no." 2971468" by spread over the units "31516" over these periods with IMR as "o" with its daily/monthly actual average consumption thereof.

ORDER

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

- 1. The Opposite Party is directed to revise the bill of the consumer for the period from Nov'2019 to 23.04.2023 basing on the consumption recorded in meter sl. no." 2971468" by spread over the units "31516" over these periods with IMR as "o" with its daily/monthly actual average consumption thereof.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
