GIST OF THE CASE

Sri Gourav Pradhan on behalf of Ulasa Pradhan appeared in the hearing on Dt. 18.08.2025 at the camp held at ESO Office, Tileibani. The complaint petition filed in the name of Sri Ulasa Pradhan, At-Baraghat, Tileibani, Deogarh, represented by Sri Gourav Pradhan, disputed about abnormal energy bill charged particularly in November-2024 billing. Hence, the Complainant prayed before the Forum to direct the Opposite Party to resolve the billing disputes accordingly.

SUBMISSION OF OPPOSITE PARTY

The opposite party submit billing abstract from Oct-2014 to July-2025, a Physical Verification Report carried out on 20.08.25 & written statement in this case. In reply to the case the opposite party submitted the following facts.

- 1. As per billing data the power supply given to consumer premises on 16.04.2018 with meter no "2497294" under 'DOM' category with CD-1.00 KW.
- 2. The bill served to consumer on actual basis up to Sept-2022 on meter number '2497294'.
- 3. The provisional bill served to consumer from Oct-2022 to May-2023 on meter number '2497294'.
- 4. The power supply was disconnected on Dt.08.06.2023 & reconnected on Dt.07.12.2024 (FG data).
- 5. Then Provisional/average bill served to consumer from Sept-2023 to Nov-2024.
- 6. The Meter No "TWSP51219570" was installed on Dt.16.12.2024 with IMR=0 (FG) and then onwards the electricity bill served to consumer on actual basis.
- 7. The opposite party suggested that, the average billing from Sept-2023 to Nov-2024 (billing period from Dt.11.09.2023 to Dt.09.12.2024) during DC period may be withdrawn.

OBSERVATION

The case is pursued with all documents available on record and merit of the complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4141-1507-0354, having CD-1.00KW under LT-Domestic category, coming under ESO-Tileibani & initial power supply effected on 16.04.2018. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- That, as per objection raised by the complainant and on examining the case in detail, the Forum observed from the soft records (FG & Samadhan App) that the power supply to the premises was disconnected on 08-Jun-2023 & reconnected on 07-Dec-2024.
- 2. That, no energy bills were charged from September-2023 to October-2024.
- 3. That, November-2024 bill was charged on average basis with "1092" units abnormally. The last actual bill was charged in July-2022, considering the current reading of KWH"000070". There were no advancement of meter readings recorded in the meter No." 2497294".
- 4. That, a new meter bearing SL. No." TWSP51219570" was installed on 16-Dec-2024, replacing the old meter No" 2497294" and actual bills continued to charge thereafter.

The Forum on scrutinizing the records & reports available on record construed that the average energy bills charged particularly in November-2024, are to be revised on the basis of succeeding six months actual monthly average consumption recorded in subsequent meter SL.No." TWSP51219570" from the date/month of installation, to redress the grievances accordingly.

<u>ORDER</u>

After careful consideration of hearing and documents, statements available on records, the Forum hereby passes order in consonance with Regulation of OERC Distribution (Conditions of Supply), Code, 2019

- 1. The Opposite Party is directed to revise the energy bills charged to the complainant consumer in November-2024, on the basis of succeeding six months actual monthly average consumption recorded in meter No" TWSP51219570" from the date/month of installation of the same, duly adjusting the bill revision made earlier and/or the benefit arising out of the OTS Scheme, if any.
- 2. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, duly considering the applicable tariff during the period, taking into account the adjustments, if any, and adjustment for the payments made by the complainant.

The Complainant is directed to pay the revised billed amount so arrived 3. within due date after receipt of the revised energy charges bill to complainant is liable to pay.

Accordingly, the case is disposed of.

The opposite party is directed to submit the compliance report to this Forum within One Month from the date of issue of this order.
