GIST OF THE CASE

The Complainant filed the petition in the name of Surendra Bhoi bearing Consumer No 4135-2603-0409 under JED, TPWODL, Jharsuguda stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-domestic consumer having CD 1.5kw with initial date of p/s 02.11.2006 as seen from the FG data base/Samadhan App. The complainant has raised objection on billing dispute. The meter sl. no" TPWODL1105300" was installed on 15.11.2022 with IMR as "zero" and MF "1" and the old kwh reading was "5790" in old meter sl. no." WCSo8o5300". The p/s has been effected through meter sl. no."026403" with actual reading "2872" and billing units "2866" in Mar'2008 with IMR as "6". The complainant lodged complaint on billing in LD periods i.e more than 01yr. The opposite party ha snot submitted anything in regards to LD. During the of hearing, it was observed that the complainant is a poor person and might be consumed less units of electricity and during that time it came to the notice of the Forum that, the p/s was in LD position. The matter has been discussed with both parties and the opposite party has agreed to provide the p/s on payment of Rs 20,000/- where the complainant given the consent on the same.

As seen, the complainant coming under CHP and hence handed over the copy of the application to the opposite party for heard the case and take the decision with the direction to re-connect the p/s accepting Rs 20,000/- from the complainant.

Hence, the instant case petition is hereby dropped.

Accordingly, the case is disposed of.
