GIST OF THE CASE

Ram Chandra Pasayat has appeared on Dt. 29.04.2024 at the camp held at ESO Office, Bandbahal and submitted a written complaint wherein he has stated about billing dispute and requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from March-2001 to March-2024, but no PVR or written statement has submitted in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 2KW with date of initial power supply 01.01.1990 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter Sl No TPWODL1036590 was installed on 03.02.2023 IMR '0' & MF 1 with old KWh 15546 recorded in previous meter bearing SL No 8061056 which was in billing in Sept-2011 with IMR '0'. The actual billing has been done by opposite party up to 16.08.2021(billing month July-2021) with Kh reading of 15546. Although date of the meter installed bearing SL No TPWODL1036590 was showing as 03.02.2023 but actually installed on 15.09.2022 as per meter installation protocol entered in FG. The meter reading on 18.09.2023 was 1332 relating to meter Sl No TPWODL1036590. As observed bill revision is required for the period from 1708.2021 to 14.09.2022 & 15.09.2022 to 18.09.2023. The opposite party has revised the bill from Aug-2023 to Aug-2023 (16.08.2023 to 18.09.2023) as seen from the FG data base.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from 15.09.2022 to 18.09.2023 by taking IMR as '0' & FMR as 1332 with reference to consumption recorded in meter SL No TPWODL1036590 with the daily/monthly actual consumption thereof and for the period from 17.08.2021 to 14.09.2022 as per the actual average consumption so derived earlier considering the adjustment of previous bill revisions as per law if any.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass to Order as follows.

- 1. The Opposite Party is directed to revise the bill for the periods from 15.09.2022 to 18.09.2023 by taking IMR as '0' & FMR as 1332 with reference to consumption recorded in meter SL No TPWODL1036590 with the daily/monthly actual consumption thereof and for the period from 17.08.2021 to 14.09.2022 as per the actual average consumption so derived earlier considering the adjustment of previous bill revisions as per law if any.
- The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
