GIST OF THE CASE

Bisakha Karali on behalf of consumer late Purna Chandra Karali has appeared on Dt. 29.04.2024 at the camp held at ESO Office, Bandbahal and submitted a written complaint wherein she has stated about billing dispute and requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from July-2002 to July-2023, but no PVR or written statement has submitted in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 2KW as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. The case will be taken up for final order after receiving the PVR, Written version & report on meter SL No 8173143. However, as a stop a gap arrangement it is decided by this Forum to restore the power supply through RC after payment of Rs.15000.00 by complainant where both parties were present & also agreed.

Hence it is the opinion of the Forum that the opposite party is liable to restore the power supply through RC after payment of Rs.15000.00 by complainant & not to DC the power supply during pendency of the case.

INTERIM ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- 1. The Opposite Party is directed to restore the power supply through RC after accepting Rs.15000.00 from the complainant & not to DC the power supply during pendency of the case.
- 2. The Complainant is directed to pay the Rs.15000.00 to opposite party to avail the power supply.

3. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.
