GIST OF THE CASE

Parikhit Patel has appeared on Dt. 29.04.2024 at the camp held at ESO Office, Bandbahal and submitted a written complaint wherein he has stated about billing dispute and requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from Feb-2012 to March-2024, but no PVR or written statement has submitted in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 2KW with date of initial power supply 25.02.2012 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter Sl No LW153835 was installed on 30.08.2019 IMR '0' & MF 1 where found the old meter bearing SL No WCG02678 was in billing since Dec-2015. As seen the billing unit was 597 in Aug-2019 and 244 in July-2019 with KWh reading of 3350 & 2733 respectively. The supressed readings wee billed during the periods for which the actual date/month of supressed reading may not be ascertained. Hence, revision is required to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from Dec-2015 to Aug 2019 (16.09.2019) by spread over the reading of 3330 units with IMR '0' in reference to consumption recorded meter SI No WCG02678 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.

<u>ORDER</u>

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- The Opposite Party is directed to revise the bill for the periods from Dec-2015 to Aug 2019 (16.09.2019)
 by spread over the reading of 3330 units with IMR '0' in reference to consumption recorded meter Sl No
 WCG02678 with the daily/monthly actual consumption thereof considering the adjustment of previous
 bill revisions as per law if any.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.

- 3. The Opposite party is directed not to consider the bill revision for the period already where the camplainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
