GIST OF THE CASE

Nirakar Pradhan has appeared on Dt. 29.04.2024 at the camp held at ESO Office, Bandbahal and submitted a written complaint wherein he has stated about billing dispute & requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from March-2001 to March-2024, a PVR carried on 06.05.2024 also submitted but no written statement has file in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 2KW with date of initial power supply 01.01.1990 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter Sl No TWST1708627 was installed on 17.02.2024 IMR '0' & MF 1 with old KWh reading of 27335 (old meter No WCG02954). The KWh reading was 27335 on 26.01.2024 as seen from Samadhan App. The meter Sl No WCG02954 was in billing since Feb 2016 but it is seen that the bills were raised on the complainant time to time although actual basis but not in accordance to the recorded consumption in the meter time to time & seems to be improper. As observed many times during billing periods high units of bills were raised i.e., supressed reading was billed in between the periods whenever desired by meter reader. '0' billing were done since Aug 2013 to April 2014 without considering FC. Hence, revision is required to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from Feb-2016 to Dec-2023 by spread over the reading of 27335 units with IMR '0' in reference to consumption recorded meter SI No WCG02954 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any and FC to be levied for the period from Aug 2013 to April 2074 accordingly.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

1. The Opposite Party is directed to revise the bill for the periods from Feb-2016 to Dec-2023 by spread over the reading of 27335 units with IMR '0' in reference to consumption recorded meter SI No WCG02954 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any and FC to be levied for the period from Aug 2013 to April 2014 accordingly.

- the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
