#### **GIST OF THE CASE**

President Pani Panchayat (represented by Mrutunjaya Pruseth) appeared in the GRF Camp held at SDO Office, Belpahar on Dt. 13.09.2025. The complainant submitted during course of hearing in brief as follows:

- 1) The complainant has complained regarding EC bills raised during non-operational period of LI point from November-2019 to December-2021.
- 2) The complainant stated that they are unable to pay EC raised during the above-mentioned period.

Previous Complain, if any: Not Available

### SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted Physical Verification Report and written version on 31.10.2025 in this case.

## Remarks given in Physical Verification Report(31.10.2025) as mentioned below:

"During site verification we found CMR=8869, Meter no."TWSC10068321". As per consumer complaint there is no power supply from Jun'2019 to Dec'2021, but there is no disconnection made this point."

### Remarks given in Written statement (31.10.2025) as mentioned below:-

- 1. The date of power supply to the consumer is 29.11.2019.
- 2. As per consumer complain the borewell was not used from Oct'2019 to Dec'2021. The power was given on Oct'2019 and disconnection was not made during that period. As per PVR report this was also mentioned.
- 3. The  $2^{nd}$  meter was installed on 08.02.2022 and as per FG old Kwh at the time of meter change was 0 Kwh.
- 4. There was a bill revision made from May'2022 for an amount of Rs 15656.49 by taking consumption of 1007 unit p.m.

Complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4170-0106-0644, having CD – 15.00 HP in LT-Irrigation category, coming under ESO – Belpahar. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- 1) Date of initial power supply is 29/10/2019. Consumer was billed provisionally from November-2019 to January-2022 without any reading although a meter having Sl. No. "2971527" was installed against the consumer number from the date of initial power supply.
- 2) Subsequently a meter having Sl. No." TPU28903" was replaced during 08/02/2022 the old defective meter having Sl. No. "2971527".
- 3) Then onwards actual bills were served to the consumer as per recorded confunction in meter taking care of adjustment of provisional bills there into, till date.
- 4) As per claim made by the complainant regarding non usage of power from November 1 December-2021, the Opposite party has submitted through written statement that the power supply was given on October-2019 and disconnection was not made during that period.
- 5) The complainant has submitted a certificate from Asst. Executive Engineer, LI Sub-division, Jharsuguda regarding nonfunctional of LI point. Asst. Executive Engineer, LI Sub-division, Jharsuguda has issued the certificate of nonfunctional of LI point without mentioning proper reason thereof. So, the certificate cannot be relayed upon without any proper reason/justification.
- 6) Also, complainant could not be able to produce any documental evidence regarding approach to Opposite Party to get the power supply disconnected during the non-operational period such as any written request or payment made for DC/RC fees.

#### <u>ORDER</u>

After careful consideration of hearing and documents, statements available on records, the Forum construed that there is beyond any scope for revision/withdrawal of previous energy bills charged during November-2019 to December-2021, in the absence of proper records justifying/substantiating the complaint petition filed.

So, the case is hereby dropped.

Accordingly, the case is disposed of.
