# **GIST OF THE CASE**

The Complainant has filed the petition in the name of Sahedal Chand bearing Consumer No 4162-3101-0243 represented by Sri Chintamani Chhanda under SEED, TPWODL, Sambalpur stated about billing dispute where stated that bills were served since 1994 to 2002 despite no power supply at the premises of the complainant.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

### SUBMISSION OF OPPOSITE PARTY

The Opposite Party has not submitted any relevant documents in this case.

# **OBSERVATION**

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 1KW with date of initial power supply 01.01.990 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute & about the bills were served even if there was no power supply at that premises since 1994 to 2002 with out mentioning specific date/month. It is difficult in the part of the Forum to pass any order without documentary evidence of both parties in this case. However, to settle the issue a special enquiry to be conducted by a committee headed by E.E, SEED, Sambalpur consisting of SDO, Dhanupali, ESO, AOT/AOC lineman etc to ascertain the disconnection period in presence of the complainant & as per outcome of the report of the committee bill revision to be taken care by waive out the billings were so made during disconnection period if ascertain the disconnection period or otherwise not to revise in such a manner.

#### **ORDER**

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

- 1. The Opposite Party is directed to conduct the enquiry by a committee headed by E.E, SED, Sambalpur consisting of SDO, Dhanupali, ESO, AOT/AOC lineman etc to ascertain the disconnection period in presence of the complainant & as per outcome of the report of the committee bill revision to be taken care by waive out the billings were so made during disconnection period if ascertain the disconnection period or otherwise not to revise in such a manner.
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier and adjust the revision as per law/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.

- The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- Opposite party is directed to submit the compliance report to this Forum within one month from the date 7. of issue of this order as the case may be.

Accordingly, the case is disposed of.
