COMPLAINANT

OPPOSITE PARTY

Ranjan Dash representative of consumer Late Sushil Dash has appeared on Dt. 17.05.2024 at the camp held at SDO Office, Kuchinda and submitted a written complaint wherein he has stated about billing dispute & requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant document in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 0.06KW with date of initial power supply 04.10.2005 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Pl/Act bills were served to the complainant for the period from April-May-2006 to Sept-Oct-2015 with KWh reading of 1469 in reference to consumption recorded in meter Sl No 1954561 was effected in billing. Pl/Avg bills were served to the complainant for the period from Nov-Dec-2015 to July-Aug-2018. Meter Sl No LW056997 was in billing in Aug-Sept-2018 & continuing till date with advance reading time to time with actual/Pl bills with adjustment of Pl amount. However, as observed table readings were served time to time as meter readers were not doing their job properly & the opposite party has not taken to rectify the same due to many reasons involved thereon. Hence, revision is required to settle the billing dispute. As this case has been file on 17.05.2024 & till date no response by opposite party for submission of documents hence, this Forum prefers to pass experte order to avoid further delay.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from April-2006 to Oct-2015 by spread over the reading of 1469 units with IMR '0' KWh in reference to consumption recorded meter Sl No 1954561 with the daily/monthly actual consumption thereof & other periods as per law considering the adjustment of previous bill revisions if any.

ORDER

After careful consideration of hearing and data submitted by both parties the For Order as follows.



- 1. The Opposite Party is directed to revise the bill for the periods from April-2006 to Oct-2015 by spread over the reading of 1469 units with IMR '0' KWh in reference to consumption recorded meter SI No 1954561 &with the daily/monthly actual consumption thereof & other periods as per law considering the adjustment of previous bill revisions if any.
- The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
