GIST OF THE CASE

Sunil Rao has appeared on Dt. 18.05.2024 at the camp held at ESO Office, R.N.Pali and submitted a written complaint wherein he has stated about billing dispute & requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted a PVR carried on 24.05.2024, no other relevant documents except PVR has been submitted in this case.

OBSERVATION & ORDER

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 1.5KW with date of initial power supply 01.10.2007 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter SI No LW585262 was installed on 01.02.2021 IMR '0' & MF 1 with old KWh as '0' with reference to meter SL No 2025335. The opposite party has already been debited Rs.6856.36 towards defective period assessment for the period from May-2019 to Jan 2021. Further, opposite party has also debited Rs.49984.00 to complainant in Nov-2019 as reported by ESO R.N Pali in its PVR towards penalty. This Forum has no authority to take decision on penalty issue.

Hence the instant case petition is hereby dismissed. However, the complainant may appear before electrical inspector Sambalpur/Jharsuguda or approach to authorities of TPWODL for settlement of the issue.

Accordingly, the case is disposed of.
