GIST OF THE CASE

Chinmaya Sa on behalf of consumer Late Labanidhar Sa has appeared on Dt. 18.05.2024 at the camp held at ESO Office, Laikera and submitted a written complaint wherein he has stated about billing dispute and request to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted a PVR carried on 24.05.2024, no other relevant documents except PVR has been submitted in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 1.5KW with date of initial power supply 12.04.2006 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter Sl No LW370945 was installed on 08.02.2020 IMR '0' & MF 1. Pl/Act bills were served to the complainant for the period from May-2006 to April-2015 with adjustment of Pl bills. Actual bill was served in April 2015 with KWh reading of 12335 with billing unit 6484 might not be genuine. The actual KWh reading was 12798 in Aug-2015 (08.09.2015) in reference to consumption recorded meter Sl No 0246908 was effected in billing since date of power supply. Further, it is also seen that Pl/Avg bills were served from Sept-2015 to Jan 2020. Hence, revision is required to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from 12.04.2006 to 08.09.2015 by spread over the reading of 12798 units with IMR 7 in reference to consumption recorded meter SI No 0246908 & for the period from Sept 2015 to Aug 2017 taking IMR as '0' on 08.02.2020 & FMR 977 on 05.09.2020 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to Order as follows.

- 1. The Opposite Party is directed to revise the bill for the periods from 12.04.2006 to 08.09.2015 by spread over the reading of 12798 units with IMR 7 in reference to consumption recorded meter SI No 0246908 & for the period from Sept 2015 to Aug 2017 taking IMR as '0' on 08.02.2020 & FMR 977 on 05.09.2020 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.
- The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.
