#### **GIST OF THE CASE**

Sri Makardhwaj Bag appeared in the hearing on Dt. 08.10.2025 at the camp held at Lakhanpur Grid, under ESO-Belpahar. The complainant submitted during course of hearing in brief as follows:

- 1) The complainant has raised objection regarding abnormal energy bills raised previously from March-2021 to February-2025 but failed to submit the nature of dispute.
- 2) To revise the EC bills as per actual meter consumption recorded.

## **SUBMISSION OF OPPOSITE PARTY**

The opposite party has submitted ledger copy for the period from Mar'2011 to Aug'2025, Physical Verification Report carried out on 22.10.2025 in this case.

# Remarks given in Physical Verification Report (22.10.2025) as mentioned below:

"There was no meter available in consumer premises."

#### **OBSERVATION**

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4172-1205-1413, having CD-2.00KW under LT-Domestic category, coming under ESO-Belpahar & initial power supply effected on 20.02.2011. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- 1) That, as per objection raised by the complainant and on examining the case in detail, the Forum observed from the soft records (FG & Samadhan App) that actual bill was charged in May-2021, considering the current reading of Kwh"5903", initial reading of Kwh"5849", recorded in meter SL.No."WCG08866", thereby auto-adjusting the provisional bill raised in April-2021 billing.
- 2) That, provisional & average bills were charged subsequently from June-2021 to January-2024 on different units from time to time.
- 3) The power supply was disconnected on 04-Mar-2024 & reconnected later on with no trace of reconnection record found in ledger. Actual bills continued to charge from February-2025 to August-2025 with last updated reading of KWH"5924" recorded in above mentioned meter.

wance **Redress at 1. 1997** sical Verification Report dtd.22.10.2025 revealed that there has been no meter available **WODL**, **Burla** - 7680 17 in the consumer premises. The Opposite Party failed to submit the physical status of the supply and written statement in support of their views to the case after giving sufficient reasonable time to furnish. Hence, the Forum could not ascertain the status of old meter with final meter readings, the power supply position & the new meter, if installed afterwards.

### **ORDER**

In the absence of proper relevant records/documents from either of the parties to extend reasonable justice to the complainant consumer, the Forum is at constraint to pass necessary orders at the

Accordingly, the case is disposed of.
