### **GIST OF THE CASE**

Bara Kumar Lakra has appeared on Dt. 27.05.2024 at the camp held at ESO Office, Tileibani and submitted a written complaint wherein he has stated about billing dispute & request to revise/rectify the same.

## **SUBMISSION OF OPPOSITE PARTY**

The opposite party has submitted billing abstract from Oct-2016 to April-2024, a PVR carried on 07.06.2024 & written statement has file in this case.

### **OBSERVATION**

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 1KW with date of initial power supply 27.10.2016 through meter Sl No WUS20960 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter Sl No WHL019812 was installed on 30.10.2022 with IMR & MF 1 in each. The KWh reading of meter SL No WHL019812 was 2715 in April 2024 billing which is confirm from the photograph of meter submitted to this Forum by opposite party. The billing unit of Dec 2022 was in higher side of 606 units. No billing has been seen since Aug 2022 to Nov 2022. Hence, revision is required to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from 30.10.2022 to April 2024 by spread over the reading of 2715 units by IMR 1in between the periods with the daily/monthly actual consumption thereof & for the period from Aug 2022 to 29.10.2022 as per the actual average consumption so derived in 1st instance considering the adjustment of previous bill revisions as per law if any

#### **ORDER**

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

1. The Opposite Party is directed to revise the bill for the periods from 30.10.2022 to April 2024 by spread over the reading of 2715 units by IMR 1in between the periods with the daily/monthly actual consumption thereof & for the period from Aug 2022 to 29.10.2022 as per the actual average consumption so derived in 1st instance considering the adjustment of previous bill revisions as per law if

any.

- The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information of the other controls. the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within from the receipt of this Order, duly considering the applicable tariff during the period, taking the adjustments, if any, and adjustment for the payments made by the complainant and ensur thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.
