GIST OF THE CASE

Judhistir Kisan (Son) on behalf of Gulbadan Kisan has appeared on Dt. 27.05.2024 at the camp held at ESO Office, Tileibani and submitted a written complaint wherein he has stated about billing dispute & request to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from Nov-2014 to April-2024, a PVR carried on 07.06.2024 & written statement has file in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 0.01KW with date of initial power supply 11.12.2012 through meter SL No 808467 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. The first bill was generated in Oct-Nov-2014 although power supply has been effected on 11.12.2012. Actual bill has been served up to billing month June-July-2018 with KWh reading of 2263 with reference to consumption recorded in meter SL No 808467. Pl bills were served for the month of Aug-2018 to Nov-2018 & in Jan-2019 put the reading of 0 for which round complete took place & generate the bill for 7737 units with billing amount of Rs.43065.74 which seems to be incorrect & abnormal. This Forum has gone through the PVR as well as W/S submitted by opposite party & found that the declaration is same with observation of this Forum. Meanwhile meter SL No LW321132 was installed on 19.05.2019 with IMR & MF 1 each. Hence, revision is required.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from Aug-2018 to April-2019 by taking IMR as 9 in Nov-Dec-2019 & FMR as 394 in March-April-2020 with reference to consumption recorded in meter SL No LW321132 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

- The Opposite Party is directed to revise the bill for the periods from Aug-2018 to April-2019 by taking IMR as 9 in Nov-Dec-2019 & FMR as 394 in March-April-2020 with reference to consumption recorded in meter SL No LW321132 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any
- 2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
